

**Sandvik Mining and Rock Solutions  
Load & Haul, Loaders and Trucks  
Extended Warranty**

The warranty provided in this document (“**Extended Warranty**”) is granted by the Sandvik, a company within the Business Area Sandvik Mining and Rock Solutions of the Sandvik Group, a global engineering group in tooling, mining and construction (“**Sandvik**”) delivering Sandvik Equipment to Purchaser. This document is to be read in conjunction with the *Sandvik Mining and Rock Solutions Standard Warranty* including (without limitation) the definitions, exclusions and limitations contained therein (“**Standard Warranty**”).

This Extended Warranty shall apply in excess of the Standard Warranty. Unless otherwise stated herein, the Extended Warranty will be governed in accordance with the Standard Warranty on Sandvik Equipment.

**1. Sandvik Equipment covered by the Extended Warranty.**

New Load & Haul diesel powered loaders and trucks when Extended Warranty is ordered as a part of the original factory order, no later than the finalization of the Sandvik Equipment Commissioning.

**2. Extended Warranty term**

Under this Extended Warranty, the term of the warranty shall be:

- 2.1. The Extended Warranty period shall commence on the same date as the original warranty period, as set out in Standard Warranty, expires.
- 2.2. Four thousand (4000) operating hours or twenty-four (24) months from the date of the completed Commissioning (whichever comes first); or
- 2.3. Six thousand (6000) hours or twenty-four (24) months from the date of the completed Commissioning (whichever comes first).

**3. Included components**

This Extended Warranty solely covers the repair or replacement of components listed below:

axles	front frame	hydraulic cylinders	engine radiator
drive shafts	rear frame	hydraulic pumps	piston accumulators (i.e. brake, steering and suspension systems)
transmission	lift arms	hydraulic valves	diesel engine (after the engine manufacturer warranty has expired)
up-box / drop-box	swing lever	hydraulic motors	electric motors (in electric loaders)
torque converter	dogbone	hydraulic coolers	

**4. Extended Warranty specific conditions**

- 4.1. The Extended Warranty is only valid when the Equipment maintenance is performed according to recommended Sandvik maintenance schedule.

- 4.2. The Diesel engine manufacturer extended warranty shall apply to the engine (must be registered locally with the authorized engine dealer).

**5. The Extended Equipment Warranty does not cover and expressly excludes any liability for:**

- 5.1. All costs and items excluded under the Sandvik Standard Warranty terms.
- 5.2. any part or component not on the list above
- 5.3. any labor costs
- 5.4. replacement of parts or components that can be repaired at lower costs
- 5.5. normal wear and maintenance
- 5.6. consumables, such as but not limited to seals, filters, hoses, v-belts, tires, fittings, screws, bolts, washers, etc.
- 5.7. electrical components such as but not limited to alternator, cable harnesses, batteries, unit control system components, trailing cable, etc.
- 5.8. bladder and membrane accumulators
- 5.9. trouble shooting costs
- 5.10. travel or accommodation costs
- 5.11. unit transportation or any freight related costs
- 5.12. tools
- 5.13. taxes
- 5.14. loss of production (or any other direct or indirect consequential costs or damages)
- 5.15. loss of use of equipment
- 5.16. failures resulting from unauthorized repairs or adjustments
- 5.17. Automine® components
- 5.18. Optimine® components
- 5.19. Radio remote control components
- 5.20. Following diesel engine components
