

**Sandvik Mining and Rock Solutions
Rotary Drills
Extended Warranty**

The warranty provided in this document is granted by Sandvik, a company within the Business Area Sandvik Mining and Rock Solutions of the Sandvik Group, a global engineering group in tooling, materials technology, mining and construction (**Sandvik**) delivering Sandvik Equipment to a Customer. This document is to be read in conjunction with the *Sandvik Mining and Rock Solutions Standard Warranty* including (without limitation) the definitions, exclusions and limitations contained therein (“**Standard Warranty**”).

This extended warranty shall apply in excess of the Standard Warranty. Unless otherwise stated herein, the extended warranty will be governed in accordance with the Standard Warranty on Sandvik Equipment.

1. Sandvik Equipment covered by the Extended Warranty

1.1. New surface rotary drilling when Extended Warranty is ordered as a part of the original factory order, no later than the finalization of the Sandvik Equipment Commissioning.

2. Extended warranty term

2.1. The extended warranty period shall commence on the date when the original warranty period, as set out in Standard Warranty, expires.
2.2. Under this extended warranty, the term of the warranty shall be six (6) months from the date set out in the clause 2.1 or a total five thousand (5000) engine hours from the date of the completed Commissioning (whichever comes first).

3. Scheduled maintenance and inspections during extended warranty

3.1. During the Extended Warranty, the Customer or its service partner, performs the scheduled maintenance of the equipment as per Sandvik maintenance program, every 250 OR 500 diesel engine hours as specified in the equipment operator’s and maintenance manuals.
3.2. In addition, Sandvik or its service partner, performs a full condition inspection of the equipment once within the 6 to 12-month warranty period.

4. Coverage

4.1. Original Sandvik components eligible for coverage under the Sandvik Standard Warranty.

5. Extended warranty specific conditions

5.1. This Extended Warranty will only be valid to the extent and on the condition that Customer complies with the following:
5.1.1. Ensure 100% conformity to recommended operation and maintenance procedures as defined in the equipment operator’s and maintenance manuals;
5.1.2. Ensure the equipment is only operated by a trained operator;

5.1.3. Ensure that all daily and weekly maintenance is performed as specified in the equipment maintenance manuals;
5.1.4. Only use genuine and Sandvik spare parts in any maintenance or repair of the machine during the Extended Warranty duration. This also includes repairs resulting from accident damage, etc.;;
5.1.5. Correct or authorize correction of any deficiencies, which could in the opinion of the Seller jeopardize components covered under Extended Warranty;
5.1.6. Use the lubricants, oils, and fuels according to Sandvik recommendations.
5.1.7. Keep hour meters in operating condition; check the operation of lubrication systems every day;
5.1.8. A claim of failure which occurs during the Extended Warranty duration must be submitted in written format to Sandvik within fourteen (14) days from the time when the Customer discovers or should have discovered the alleged failure;
5.1.9. Component failure must result from a verifiable defect within the component and/or improper manufacture;
5.1.10. If the part during inspection is found to be defective in material or workmanship, Sandvik shall provide, at its election, either a new part or an authorized factory rebuilt part.

6. The Extended Equipment Warranty does not cover and expressly excludes any liability for:

6.1. All costs and items excluded under the Sandvik Standard Warranty terms
6.2. Natural wear and tear of the equipment, normal maintenance service, adjustments and inspections, or normal replacement items (such as service filters), and damage resulting therefrom;
6.3. Consumables, including but not limited to, oils, fluids, seals, filters, fittings, fasteners, drilling tools and accessories, etc.;;
6.4. Parts which can be repaired or corrected with minimal action such as changing of seals (such as pump shaft seals), tightening or adjustment etc.;;
6.5. Damage caused by the Customer’s failure to store, maintain or operate the equipment properly, or due to overloading or failure to pay proper attention to service and operating instructions, or caused by accident;
6.6. Damage caused by negligence or failure of Customer to maintain the equipment in accordance with Sandvik maintenance recommendations;
6.7. Any defects in materials provided by the Customer or any defects caused by design stipulated by the Customer;
6.8. Any parts or components manufactured or supplied by third parties or damage caused by such parts or components to the equipment;
6.9. Any indirect or consequential damage including but not limited to loss of profit, loss of production, loss of use of equipment;
6.10. Product improvements made available by Sandvik.
6.11. Diesel engines are not covered under Extended Warranty. Diesel engines must be registered with and are



warranted directly by the engine manufacturer not Sandvik.

6.12. Warranty claims under fifty USD (\$50) are not considered by Sandvik.
